<u>PLEDGE OF ALLEGIANCE</u> – The Pledge of Allegiance was followed by a Moment of Silence for our men and women serving around the world in harm's way.

Mr. Hamilton stated that Ms. Pedro wished to speak prior to the meeting.

Ms. Pedro stated the following:

"After reflecting on my vote last night in regards to ratifying the Finance Director appointment, I'd like to change my vote. I cannot support the appointment of this position. I'd like a chance to explain why.

When I was in the middle of speaking with the Candidate, Ms. Mills, about the difference between CPA and non-CPA status and why I thought that was important, Mr. Rainer had an outburst that surprised and distracted me.

During this outburst he called my opinion an "implication" to which I take offense. It's my job as an elected official to ask questions and speak for the people that elected me to be their voice.

To me, the "implication" of this outburst is that I'm not supposed to question anything or give my opinion

When, in fact, this council is the only supervision that Mr. Rainer has. Since I was cut short during my exchange with Ms. Mills, I want to point out that she has held so many different positions that it averages out to about 2 ½ years per position. Yet she stated that it will take her 3 years of classes to get her CPA status back. I also never found out who will pay for these classes. Nothing personal against Ms. Mills, I don't even know her, I'm just not comfortable with this.

Moving forward, especially through this budget process, I will continue to do my due diligence by asking questions and voicing my opinion. And I would like to continue without intimidation or the implication that it is not my right to do so."
