- 4. Mr. Kelly would like to add the additional \$10,000 that the Portsmouth Senior Center requested.
- 5. Mr. Kelly would like to add the additional \$5,145 that the Portsmouth Free Public Library requested.

- 6. Ms. Ujifusa would like to add the \$20,825 that the Common Fence Point Arts, Wellness, Community Center requested.
- 7. Mr. Aguiar would like to add the \$1,000 that the Eastern RI Conservation District requested.
- 8. Ms. Ujifusa would like to add the \$5,000 that the Clean Ocean Access requested.
- 9. Mr. Katzman would like to add \$80,330 to the Prudence Island Volunteer Fire Department budget.
- 10. Mr. Kelly would like to add \$2,000 to the Town Council contingency fund for professional development.
- 11. Mr. Kelly would like to add \$30,000 to the DPW Grounds line for the 3 playgrounds.
- 12. Ms. Abbott would like to add \$110,000 to the Capital Improvement Plan budget to replace the Sandy Point Beach bath house.
